It is indirectly owned as to 70% by BEWG and is principally engaged in cleaning, collection and transportation of urban household waste in the PRC. The remaining 30% shareholding of Kunming Wuhua is owned by Kunming Longitude and Latitude Environmental Hygiene Service Co., Ltd.* (昆明經緯環衛服務有限公司), a company incorporated in the PRC with limited liability and is principally engaged in environmental sanitation management; municipal facility management; household services; property management; greening management; sales, installation and maintenance of environmental sanitation facilities; recycling and wholesale of recycled materials; motor vehicle leasing, etc. The ultimate beneficial owner of Kunming Longitude and Latitude Environmental Hygiene Service Co., Ltd.* (昆明經緯環衛服務有限公司) is Environmental Sanitation Management Office of Wuhua District, Kunming City* (昆明市五華區環境衛生管理處) under the local municipality government of the Wuhua District, Kunming City, the PRC.
